As a first-generation college student, Pierce earned degrees from Cornell University and Princeton University. She is delighted to partner with TJC in supporting their work to uphold the human dignity of all persons.

John T. Winemiller is a partner at Merchant & Gould PC, where his practice focuses on intellectual property counseling, enforcement, and litigation. He serves as the firm's Chief Diversity Officer and manages the firm's Knoxville office. Prior to becoming an attorney, John taught music history and theory at the State University of New York at Stony Brook. He recently completed two five-year terms as a commissioner of Knoxville's Community Development Corporation, Knoxville's public housing authority.

Jonathan Steen is the Medical-Legal Partnership Director at West Tennessee Legal Services. Working alongside medical professionals, he helps provide comprehensive legal support for challenges such as unsafe housing, denied benefits, and domestic violence—improving health outcomes and fostering stability for families in West Tennessee.
