TENNESSEE JUSTICE CENTER AND METROPOLITAN DEVELOPMENT AND HOUSE AGENCY HOST THE FIRST ANNUAL COMMUNITY PARTNERSHIP AWARD CEREMONY

The Tennessee Justice Center (TJC) and the Metropolitan Development and Housing Agency (MDHA) co-hosted our first annual Community Partnership Luncheon and Service Awards on Thursday, December 8, 2022. A little over a year ago TJC began the necessary work of meeting our neighbors and getting to know the Napier Sudekum neighborhood, a community we are soon to call home once our new building is completed early next year on (NAME OF STREET).

Over the past year, we collaborated with community-based organizations and community members to host and promote resources and services, identify needs and barriers, and look for ways that we could best serve our neighborhood. We hosted parent and caregiver exhibitions, vaccine events, record expungement clinics, driver's license reinstatement clinics, listening sessions, and events for the entire family.

The awards luncheon was filled with a celebration of local heroes and leaders committed to endless service projects and initiatives in the Napier Sudekum neighborhood.
